EXECUTIVE SUMMARY

The Central Academy for State Forest Service (CASFOS), Burnihat under the aegis of Directorate of Forest Education (DFE), Ministry of Environment, Forest and Climate Change, took a step ahead of its mandate and conducted three days training programme for Teachers & Students of Eco-Clubs and Educational Institutions from 11th to 13th October, 2022 on the theme "Conservation Education" as part of Training of other Stakeholders programme. The Ministry of Environment, Forest and Climate Change, Government of India sponsored this training and hence this training programme on "Conservation Education" theme for Teachers & Students of Eco-Clubs and Educational Institutions was planned and organised. The training was conducted on Offline mode. 35 participants from 2 States i.e. from Assam and Meghalaya participated with overwhelming enthusiasm in this training programme.

The National Green Corps (NGC) popularly known as "a programme of Eco-clubs" is a nationwide initiative of the Ministry of Environment, Forest and Climate Change launched under the Environment Education Awareness and Training (EEAT). The scheme is being operated through Eco-clubs of 25-30 students having interest in environment related issues, formed in member schools. Eco clubs are supervised by a Teacher In-charge, who is selected from among the teachers of the member school.

The Course was inaugurated by the Chief Guest Mr. M K Yadava IFS, Principal Chief Conservator of Forest and Head of Forest Force, Government of Assam. The Course Director of the training, Shri C. A. Rahman IFS (Retd.), Consultant-C (Contractual Training Faculty), CASFOS, Burnihat welcomed the Chief Guest & participants and gave a brief presentation about the Course. Dr. C. Ramesh, Principal in his opening remarks emphasized the role of teachers in shaping the future of the country and expressed his belief that this training through sensitization of teachers, particularly the teachers in-charge of Eco-Clubs and students would achieve the goal of nature conservation. He urged the participants to observe their immediate natural environment including flora & fauna for better understanding of the nature. The Chief guest, Mr. M K Yadava IFS PCCF & HoFF, Government of Assam in his inaugural address told that the school education system through Eco clubs gave space to the young minds to think and do out of the box beyond the curriculum and know about the importance of environment. He further emphasized that Eco clubs not only have impact on students but also on the parents and the neighborhood. He asked to strengthen the existing linkage between the Forest department and Eco clubs

to make the Environment Conservation efforts effective and efficient. And he also mentioned that assessment of Eco clubs is also needed and do play a role in mobilizing resources in Environment Conservation.

Guest Speakers/Resource persons like Dr. Pranav Trivedi, Conservationist, Navsari, Gujarat, Mr. S. Karthikeyan, Naturalist, Jungle Lodge Resorts, Karnataka, Dr. Narayan Sharma, Assistant Professor, Cotton University, Guwahati, Mr. C. Srinivasan, Project Director, Indian Green Service, Vellore, Tamil Nadu, deliberated on various Environment Conservation related topic in this training programme. The topics covered in this training were Overview of Conservation issues in India; Back to Nature; Wildlife amidst humans; Citizen Science and Integrated & Sustainable Solid and Liquid Resource management (SLRM). Besides the Lecture room sessions, the participants were taken for a Nature Walk and Bird watching in the morning for two hours on 12th &n 13th Oct. 2022; and also, the demonstration of some of the activities under SLRM programme. Mr. D. Mathur IFS(Rtd), Former Principal Chief Conservator of Forests and HoFF, Government of Assam was Chief guest in the Valedictory session and handed over the Certificate of Completion to the participants. In his valedictory speech, he also emphasized and urged the teachers and students to come forward and work for the message of Conservation of Natural Resources and environment among the common people and students. The detailed time table showing session-wise topics and Resource Persons is enclosed as Annexure- 4.

A total of 55 teachers & Students from 02 states (Assam & Meghalaya) registered for the training out of which 35 participants (13 teachers & 22 Students) participated in the training programme of which 10 and 25 were female and male respectively. The training programme was very well appreciated by the participants who also requested for more of such training programmes regularly, for keeping up the momentum of environment conservation ideas. They also requested for State and district level trainings of teachers in charge of Eco clubs for maximum participation of Schools and Colleges. The Participants also urged for collaboration of Forest Department and Education Department in the States for effective implementation of Environment Conservation at the field level.

The soft copies of the presentations made by the experts in each session were provided to each participant as part of the training kit/ material in pen drive.








PARAMETER WISE FEEDBACK OF RESOURCE PERSONS
