ANNUAL REPORT (2021-22)

Name of the Academy: **Central Academy for State Forest Service, Dehradun**

Ministry / Division: **Ministry of Environment, Forest & Climate Change, New Delhi**

1. About the Academy –Brief Introduction and objective:

The Central Academy for State Forest Service, Dehradun is one of the three premier forest institutes in the country for imparting training to State Forest Service personnel. The other two Academies are in Coimbatore (Tamil Nadu) and Burnihat (Assam). These three Central Academies for State Forest Service are under the administrative control of Directorate of Forest Education, Ministry of Environment, Forest & Climate Change, Government of India.

The Primary mandate of the Academy is:

- a. Imparting Professional Training in practical forestry and related subjects at the induction stage to the newly recruited State Forest Service Officers.
- b. Conducting workshops and short-term refresher courses for the in-service State Forest Service Officers.
- c. Two days trainings for other stakeholders and personnel of other services.



2. Details of Induction Trainings of SFS Officers conducted during 2021-2022 :-

2.1 2019-21 SFS Course

The Induction Training of SFS 2019-21 Course at CASFOS Dehradun commenced from 08th July 2019. Forty Nine Officer Trainees (OTs) from Uttar Pradesh, Madhya Pradesh, Himachal Pradesh, Bihar and Mizoram joined the training.

Online East India tour

The East India Tour was conducted through online mode due to COVID-19 Pandemic from 03 May, 2021 to 13 May, 2021. The main themes covered during this tour were management of protected areas, botanical gardens and zoological parks, community-based ecotourism and community forestry among other things.

Online North India Tour

The North India tour was organized from 17th May, 2021 to 28th May, 2021. The tour schedule enabled the OTs to get a first hand vista of agro forestry systems, high altitude vegetation, ex-situ and in-situ wildlife conservation, conservation breeding of various species, ecotourism, eco-development, hydroelectric projects and watershed management among others.

Working Plan Exercise

The trainees undertook the Working Plan Exercise from 2nd to 8th June 2021 at FRI, Dehradun. The exercise consisted of rigorous field work with intensive sampling, data analysis and creation of GIS layers by the OTs and writing a detailed Working Plan for FRI, Dehradun. During this exercise, the trainees put to use all the inputs received previously in the course of the SFS induction training.

Ecological Census Techniques Exercise

The trainees undertook the Ecological Census Techniques Exercise in the Rajaji National Park, Haridwar from 22 June, 2021 to 25 June, 2021. The exercise was done scientifically using the latest methodologies. Officer Trainees also submitted the detailed Census report at the end of the exercise.

Weapons Training & Motor Driving

Weapons Training and Motor Driving modules that were scheduled in the month of May and June 2021 were conducted at IMA & FRI, Dehradun.

Convocation

Because of prevailing social distancing norms, the online Convocation of the 2019-21 SFS Batch was organised on 07th July 2021. The Chief Guest for the function was Sh. Sanjay Kumar, Director General Forests and Special Secretary, Ministry of Environment, Forest and Climate Change. The other dignitaries who attended the convocation apart from the officers and staff of Director, Forest Education and CASFOS included Director, IGNFA, Director General, FSI, Senior Forest Officers and Scientist from ICFRE, FRI, IGNFA, WII, FSI. The Principal Chief Conservator of Forests from various States like Uttar Pradesh, Madhya Pradesh, Himachal Pradesh, Bihar and Mizoram also attended the online convocation. The parents and relatives of the passing out Officer Trainees were also connected through YouTube live streaming. Total 49 Officer Trainees successfully completed their training and received their diplomas. Out of the 49 passing out trainees, 12 received Honours diploma.

2.2 2021-23 SFS Course

The Induction Training of SFS 2021-23 course commenced from 2nd August, 2021 comprising of 33 Officer Trainees as per details given below:-

- 2- West Bengal- 8
- 3- Nagaland- 2
- 4- Maharashtra- 1
- 5- Meghalaya- 4

Introductory Tour:

The SFS Course 2021-23 OTs camped in tents at Kanasar and Chakrata from 6th to 11th September 2021. On their return to CASFOS, Dehradun, the OTs underwent introductory tour exam and symposia was conducted on various topics covered during the tour. They also submitted Tour Journals and Herbarium individually to the Course Director. After the Introductory tour, the OTs underwent classroom and practical sessions at CASFOS, Dehradun.

West India tour

The West India Tour covering the States of Uttar Pradesh and Rajasthan was conducted from 10th to 24th October, 2021. The main themes covered during this tour were management of protected areas, eco- restoration, energy efficient and green buildings, community based ecotourism and community forestry among other things.

West India Tour Case Study

The trainees undertook the West India Case Studies tour covering the States of Maharashtra, Madhya Pradesh, Rajasthan and Gujarat from 29th November, 2021 to 07th December, 2021. The main themes covered during this tour were Man-Animal Conflict, Livelihoods, Management of Protected Areas, Zoological Parks, community based ecotourism and community forestry. It was followed by presentations of case studies at CASFOS, Dehradun.

East India tour

The East India Tour covering the states of Odisha, West Bengal, Meghalaya and Assam was conducted from 20th December, 2021 to 08th January, 2022. The main themes covered during this tour were management of protected areas, botanical gardens and zoological parks, community based ecotourism and community forestry among other things.

Watershed Management Plan Exercise:

As part of Natural Resource Management Course, the Officer Trainees were attached with Watershed Management Directorate (WMD) of Uttarakhand at Thatyur, Tehri Garhwal for undergoing one week module on Land Use and Watershed Management from 23 February, 2022 to 25 February, 2022. The exercise not only developed PRA and watershed management skills among the trainees but also changed their attitude to become more people friendly and adopt a solution based approach while solving people and natural resource management issues.



Ecological Census Techniques Exercise

The trainees undertook the Ecological Census Techniques Exercise in the Shivalik Forest Division, Saharanpur (U.P.) from 06 March, 2022 to 15 March, 2022. The exercise was done scientifically using the latest methodologies. Officer Trainees also submitted the detailed Census report at the end of the exercise.

- Dr. Dhananjai Mohan is 1988 batch officer of Indian Forest Service, Uttarakhand cadre. Before taking over as Director Wildlife Institute of India, Dehradun in January 2020, he served as Principal Chief Conservator of Forests, Planning and Financial Management and Chairman State Biodiversity Board, in the state of Uttarakhand. He earlier served in the wildlife headquarters of Uttarakhand Forest department for over five years.
- He is a graduate in Electrical Engineering from IIT, Kanpur.
- He has managed protected areas in undivided UP and written management plans for many of them. He did his Post-Graduate Diploma in Wildlife Management in the year 1992. He was awarded a Ph.D. degree on 'Habitat selection of birds in New Forest, Dehradun, India' by Wildlife Institute of India center of Forest Research Institute University, Dehradun.
- He served as an Associate Professor in the Indira Gandhi National Forest Academy, Dehradun from 1998 to 2004 dealing with the subject of wildlife conservation.
- He has undergone short courses on 'Biodiversity Conservation and Management' at the University of Wales, Bangor, UK and Colorado state University, USA.
- Later he served as Professor in the Wildlife Institute of India, Dehradun from 2006 to 2013 where he led avifaunal research and collaborated with University of Chicago to conduct research on Himalayan bird diversity gradient. He has written a book and contributed a book chapter and has many publications particularly on avifauna, his primary interest. Some of these were published in topmost international journals like Nature, Nature communication, American naturalist, Biology letters and Journal of Ornithology. Dr Mohan has been a passionate birdwatcher and naturalist for nearly four decades and has spanned the length and breadth of the country in pursuit of it..
- Dr. Dhananjai is a fellow of Leadership for Environment and Development (LEAD), a Programme initiated by the Rockefeller foundation. He has been a recipient of Dr Salim Ali fellowship of Ministry of Environment and Forests, Govt. of India in 2005. He served as a consultant to TERI and supervised a doctoral research and 6 M.Sc. dissertations in wildlife science and forestry.
