EXECUTIVE SUMMARY

Central Academy for State Forest Service (CASFOS), Dehradun, Uttarakhand (UK), under the aegis of Directorate of Forest Education (DFE), Ministry of Environment, Forest, and Climate Change (MoEF&CC) has a mandate to conduct various theme-based short-term training programs. In this regard, CASFOS, Dehradun organized a 3-day Training for Other Stakeholders on **“GI as a tool for the conservation of Natural Resources”** between 07.05.2025 and 09.05.2025 for **Members of Trade associations involved in NTFPs, MFP federations, Producer Groups/companies and Research Associates, Forestry Professionals in Non-Govt. sector.** The training program was conducted at the Academy with a total of 06 technical sessions by Subject Matter Experts, and a full day field visit coordinated by the Course Director. A total of 55 nominations from 19 states were received out of which 41 participants from 14 states attended the training.

The training was inaugurated in the presence of Shri E. Vikram, IFS, Principal, CASFOS, Dehradun on 07.05.2025. In the opening remarks, Shri E. Vikram, IFS, stressed upon the importance of community level efforts towards conservation and importance of GI as a tool for foresters towards achieving this goal. Usage of GI will result in livelihood improvement in these communities and a lot of scope for research is there for the trainees and states in this domain. He welcomed all the participants to CASFOS Dehradun. Dr. Pawan Kumar Pandey, Deputy Registrar of TM, GI & CR delivered the keynote address. He talked about the market opportunities out of GI tag & value, which also gives regional identity to products.

The Valedictory session was presided over by Shri E.Vikram, IFS, Principal, CASFOS, Dehradun, during which verbal feedback of the participants was also taken. In his Valedictory address, he said that the participants of the program have become ambassadors for GI, and they have benefitted from cross learning during this program. Future surveys are important in this sector, and they will carry it out in their respective states. Sh. Amlendu Pathak, IFS, Course Director, gave a presentation about the program and concluded the program with a vote of thanks to the entire team and to the participants. The participants gave an overwhelming response to the course.

The academy also conducted Training Need Analysis (TNA) on the last day of the program for which the participants were divided into 3 groups and one faculty from the academy conducted the session. Focus group discussion resulted in fruitful suggestion for improvement in future training programs as per the feedback given by the trainees.

A compendium of articles, presentations related to the relevant topics covered during the course, apart from the copies of the presentations made by the experts in each session were provided in soft copy to each participant as part of the training kit by the Academy.

The overall impact of the course/workshop was positive and the feedback and high rating from the participants corroborates the assessment of the organizers.

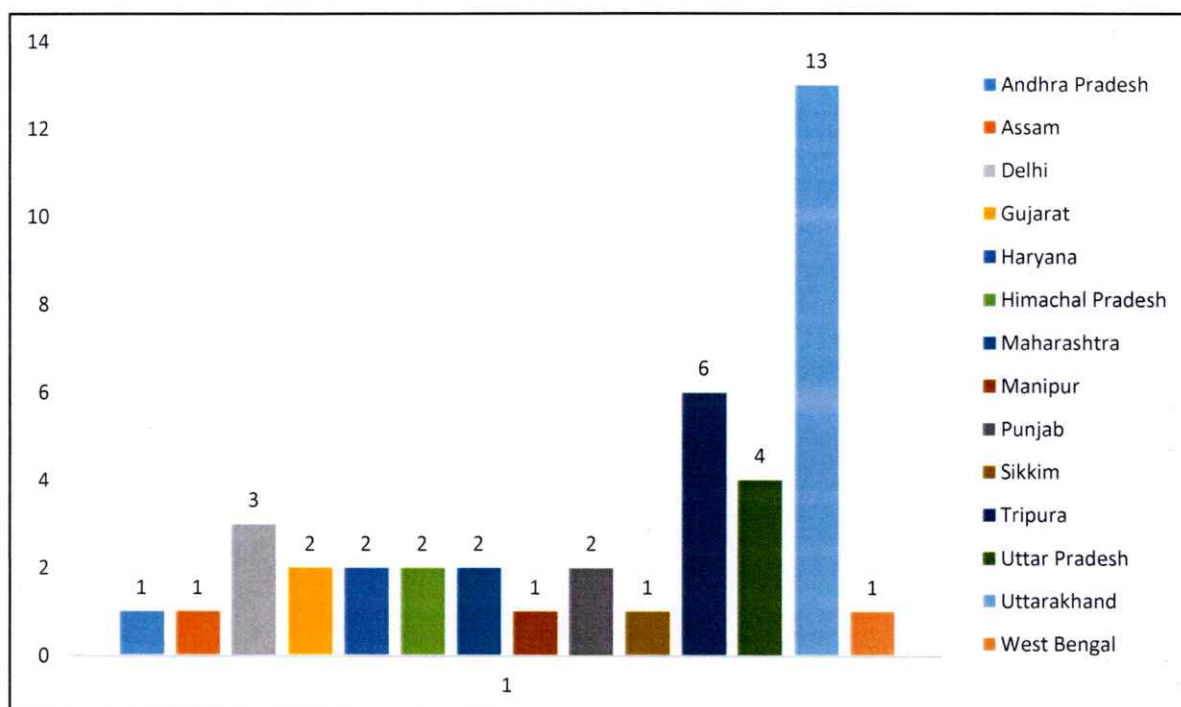

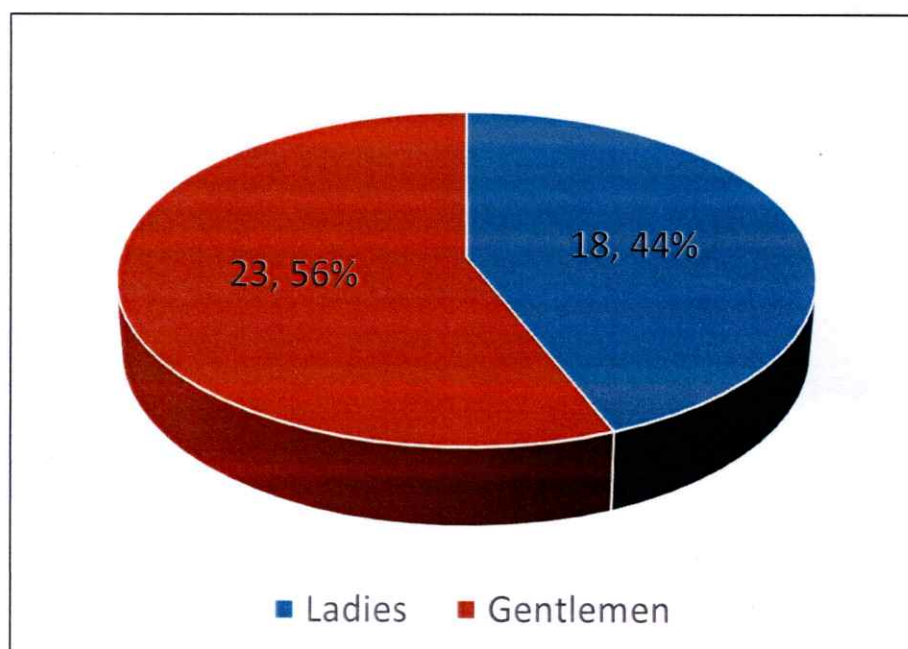




Parameter wise breakup of feedback of Resource Person

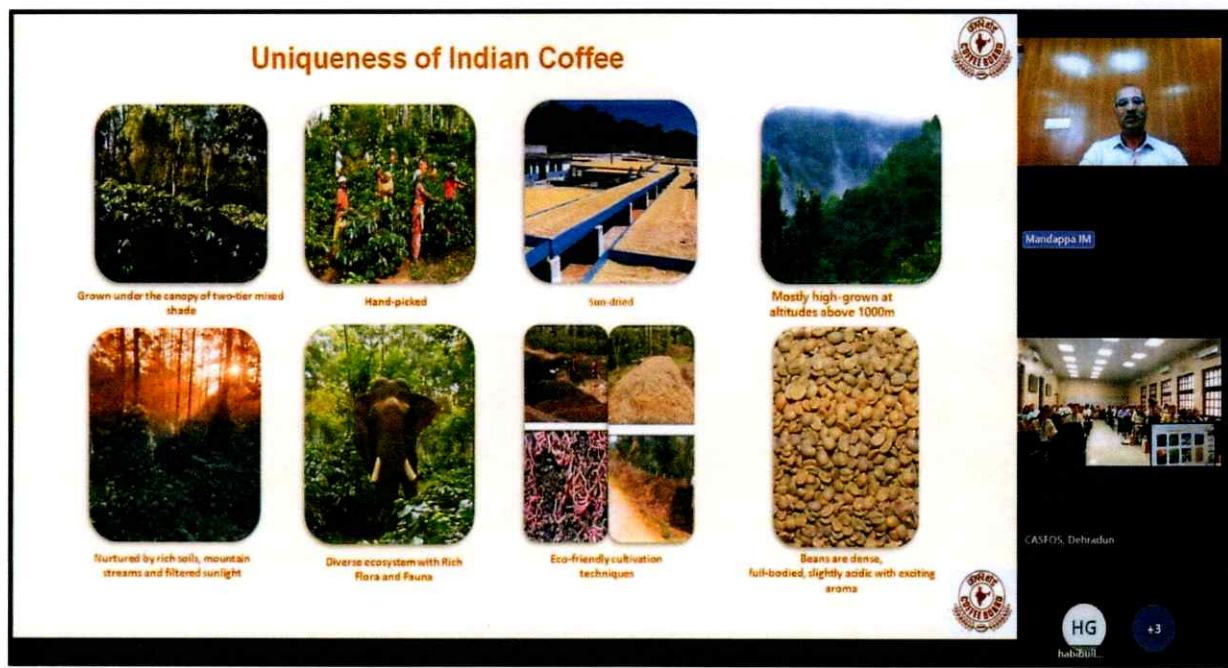

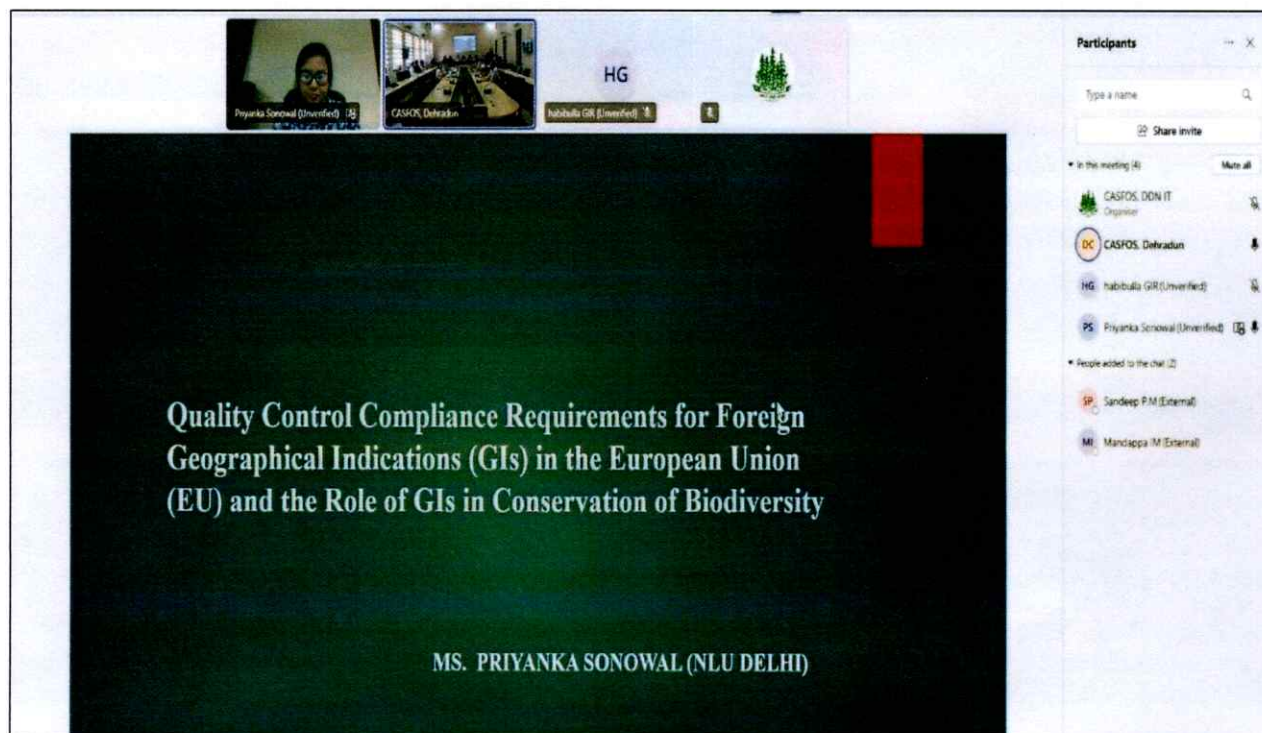

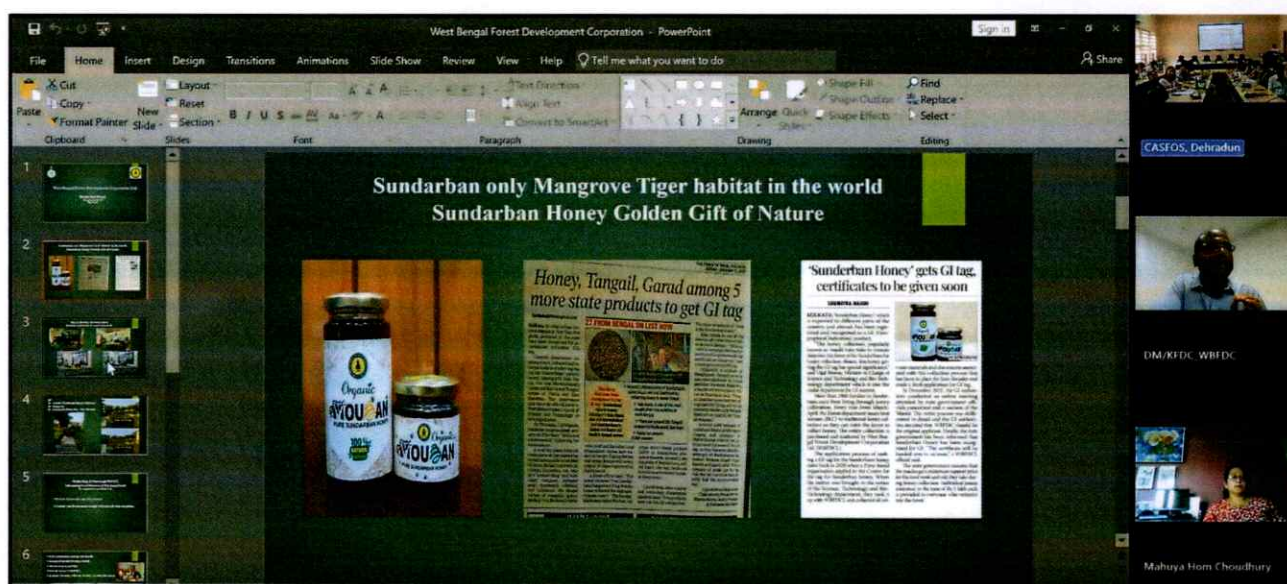
