# **EXECUTIVE SUMMARY**

Central Academy for State Forest Service (CASFOS), Dehradun, Uttarakhand (UK), under the aegis of Directorate of Forest Education (DFE), Ministry of Environment, Forest, and Climate Change (MoEF&CC) has a mandate to conduct various theme-based short-term training programs. In this regard, during F.Y. 2024-25, CASFOS, Dehradun organized a 3-day Training for Personnel of Other Services on "**Wildlife Trade & Trafficking**" between 05.03.2025 and 07.03.2025 for Class II & III Officers of Police, Customs, CISF, ITBP, RPF, IB, DRI, ED, Commercial Tax Department, etc. The training program was conducted at the Academy with a total of 11 lecture sessions by Subject Matter Experts, and a full day field visit coordinated by the Course Director. Total 32 nominations of officers from 04 states was received out of which 30 participants from 04 states attended the training.

The training course began with an inauguration on the first day, i.e., 05.03.2025. The Course Director of the training Mr. Amlendu Pathak, IFS, Lecturer, CASFOS, Dehradun gave a brief presentation about the course and structure of the training program, followed by opening remarks and address of the Principal, Mr. E. Vikram, IFS. He warmly welcomed all the participants to the training program at the Academy in sylvan campus of the Forest Research Institute. In his address, the Principal mentioned the importance of such training programs for the officers of the security agencies of the country. He also emphasized on awareness generation to curb the menace of illegal wildlife article trade in the country. The inaugural session was also attended by Dr. Kirupashankar M., Joint Director, WCCB (Hq), New Delhi and his team.

Important topics and sessions during the training program were Wildlife crime scenario and statutory wildlife crime enforcement framework in India, Role of enforcement agencies in combating wildlife crime, Relevant provisions of Wildlife Protection Act- Schedule & Offences, Powers vested with enforcement agencies and procedures, etc. The trainees were taken to Wildlife Institute of India, Dehradun and given exposure there.

The training course ended with a valedictory-cum-interactive session on 07.03.2025. The Course Director briefly summarized the 3- day long course and Participants gave their verbal feedback regarding the course. The course was highly appreciated by all and gave an overwhelming response to the course. Participants suggested incorporating such programs during their initial, training phase in the academies. After feedback, course completion certificates were distributed to the participants followed by Address of the Chief Guest, Mrs. Meera Iyer, IFS, Director, Directorate of Forest Education, Deheradun. The DFE interacted with all the participants and highlighted the importance of feedback for improving future programs and congratulated all for successfully completing the course.






## **Overall Feedback of Resource Persons on all Parameters**
