Terms & Conditions:

1. Period of contractual engagement:

01 Year, that may be extended by another year subject to requirements and satisfactory performance.

2. Eligibility Criteria:

Eligibility criteria is applicable as mentioned above.

3. Remuneration/honorarium:

Per-day remuneration/honorarium is mentioned in column 5. The services are expected to be provided for 02-03 days maximum per week as per actual requirement upon approval of the Principal, CASFOS, Dehradun.

No extra entitlement of any allowance etc. such as Dearness Allowance, House Rent or Residential Accommodation, Telephone, Personal Staff, CGHS, Medical Reimbursement etc. shall be admissible. For outstation assignments, the expenses on travel, lodging and boarding etc. shall be borne by the Academy as per applicable rules and norms.

4. Selection:

Mode of Selection: The applicants fulfilling the eligibility criteria shall be shortlisted on the basis of qualifications and called for test and interview to be conducted by a committee appointed the Principal, CASFOS.

The persons attending the test and interview shall bear the expenses for travel etc. on their own. The CASFOS shall not pay/reimburse any expenditure for this purpose and shall not be liable to make any arrangement for lodging and boarding for outstation candidates.

5. Tasks and Works Assignments, Attendance & Working days, Absence & Leave: -

- (i) The Physical Training & Sports Associate engaged / appointed on contract shall perform the duties of his/her professional / vocational specialization and other related works as assigned by the Officer-in-Charge Sports or other officer assigned by the Academy.
- (ii) The working hours for Physical Training & Sports Associate on regular working days of the Academy will be scheduled and notified by the Academy from time to time. In case of occasional requirement of working beyond the scheduled period or on Sundays / Gazetted holidays, or in case of special events and occasions, no extra- remuneration/honorarium will be admissible. However, compensatory leave in such cases shall be the discretion of the Officer in Charge Sports or other officer assigned by the Academy.
- (iii) The Physical Training & Sports Associate(s) shall mark their attendance in the prescribed register.

(iv) Absence & Leave Provision.

- (a) In case of absence on a particular and scheduled day, the officer may take up the same session on the very next working day or the day as scheduled by the Officer in Charge (OIC) Sports.
- (b) The leave shall be availed normally with advance intimation to the OIC, Sports or other officer assigned by the Academy.

6. Integrity Certificate:

The Selected candidates shall provide integrity certificate from 2 references known to them.

7. Conflict of Interest:

- (i) The Physical Training & Sports Associates engaged by the CASFOS shall be expected to display utmost honesty, sincerity, confidentiality, and good conduct while discharging duties. In case the services of the Physical Training & Sports Associate engaged are found in conflict with the interests of the Government/ CASFOS or unsatisfactory, his / her engagement will be liable for discontinuation/termination without assigning any reason;
- (ii) During the period of contractual engagement in the CASFOS, the Physical Training & Sports Associates, would be subject to the provisions of the Indian Official Secrets Act, 1923 and will not divulge any information gathered by him during the period of his assignment to anyone who is not authorized to know the same.
- (iii) A Self-undertaking shall be provided by the candidate to the effect that he/she has no criminal record or criminal case in any court is pending against them
- (iv) In case of retired persons this engagement/employment shall not be considered as reemployment in service.
- (v) A person appointed on a contract basis can be assigned, works additional to the specific task for which appointed, or other duties by the Principal, CASFOS, as deemed necessary.
- (vi) The appointment can be discontinued by the Principal, CASFOS during the contract period at any time without assigning any reasons. The appointee shall not have any claim, whatsoever for regular appointment on any position on the basis of contractual appointment. The same shall be given as an undertaking before joining.
- (vii) The appointing authority for such appointments will be the Principal, CASFOS.
- (viii) The number prescribed per sport is tentative and the appointing authority reserves all the right to cancel/add/reduce the said numbers of personnel to be hired.
